## 5.3 Accessing advocates and support



#### Introduction

As a parent of a child with a spinal cord injury you might have concerns ranging from education, access to services, respite and your other children's needs. This section is about letting you know about some of the support that is out there. This support can bring you together with other parents who have child with a spinal cord injury, or organisations that can provide advice and support.

#### Mentoring service at Back Up

We understand that spinal cord injury affects the whole family. Families who have children and young people with a disability very often deal with similar issues and challenges. Family mentoring is a service to support parents and partners of people with spinal cord injury. Being introduced to an experienced mentor parent could help you feel more positive about what the future may hold for you and your family.

## Online forum for parents

<u>Parents of disabled children</u> is an online forum that aims to bring families together for friendship, to share information and to support one another. The forum was created by parents who have children with special needs and is run by parents.

## **Supporting siblings**

Stoke Mandeville spinal injury centre runs events for brothers, sisters, relatives or friends who are children and are connected to a person with a spinal cord injury. In March and November, they host a 'Relatives Day' for children aged 6-16 where they can meet other people affected by spinal cord injury. The purpose is to raise awareness, play fun games, talk about their experiences, express feelings about their brother or sister or friend.

Siblings have a lifelong need for information; they often experience social and emotional isolation, and have to cope with difficult situations.
